ASHLAND CITY COUNCIL REGULAR MEETING

August 5, 2021

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 5th day of August, 2021 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on July 29, 2021. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Council President Anderson called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. President Anderson noted the Open Meetings Act located on the south wall of the room.

Motion by Niemeyer, second by Wischmann to approve Resolution 2021-16 — Authorizing the City to Declare a Plan for Acquisition of Real Property for the Present Public Purpose of Constructing a Public Works Facility and Authorizing the Acquisition of Property Located Generally at 602 Dennis Dean Road.

Zoning Official Krejci said he was a member of the committee assigned to study potential sites for a new Public Works facility. He said the committee reviewed several properties around Ashland looking for potential sites to construct a new building to house the street department. He said the committee felt this piece of property would suit the City's needs and the City has finances already in the property. He added the existing Public Works facility is too small, is inadequate, has some structural issues and is on main street. City Attorney Fahleson said a new

building would allow for inside storage of equipment, keeping the equipment in better shape and saving the city money in the long run. Council Member Niemeyer said there is a safety aspect as well, as there is not room to move or to adequately work on equipment. He said it is time and the City has about \$60,000 invested in the property from the nuisance clean up. Council President Anderson said it bothers him that equipment sits outside and that the facility is out of room. He added it will be a plus for the community. Council Member Wischmann said this will help get everything inside in one central location.

She said this was the last time the City had heard from Krueger. Council Member Niemeyer suggested the firm be contacted to determine what they have done for Krueger. She said Building Official Krejci had told Krueger not to do anymore work until someone looked at it to determine if it is structurally safe. Council President Anderson said he is not in favor of anymore extensions.

Wischmann said it is not just about how the structure looks but it is a liability issue if someone gets hurt on the property. Anderson said the structure is being used for storage.

AAEDC Executive Director Caleb Fjone said their annual meeting will be on Tuesday. He said he is submitting an application to NEDA to be the host city for their 2022 conference.
