September 2, 2021

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 2nd day of September, 2021 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on August 26, 2021. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act located on the south wall of the room.

Ron Styskal gave public comment about the Beetison House. He provided information from the US Department of Interior and the State Historical Society regarding the house. He said an acre of land goes with the house; if the house is moved, it will no longer be on the historic site list; and he would hate to see the community lose the history that goes with the house. He also commented that trees along the streets on the east side of town need to be trimmed.

City Administrator Quady reminded the Council that the public hearing for the budget must be at a separate meeting. She said the hearing is scheduled for 6 p.m. on September 16, 2021.

She said they will be using hay bales to designate the area. Mayor Grauerholz recommended to the Council that the request be denied due to clean-up issues at a similar event held two years ago. Discussion followed. Council Member Niemeyer commented the panels the Chamber uses for events would be available and he would like to have the event as it can be positive for downtown.
