

## ORDINANCE 1185

AN ORDINANCE OF THE CITY OF ASHLAND, SAUNDERS COUNTY, NEBRASKA, TO AMEND SECTION 6-318 OF THE ASHLAND MUNICIPAL CODE TO PROVIDE FOR THE REGULATION OF UNLICENSED AND INOPERABLE VEHICLES; TO PROVIDE FOR THE REPEAL OF ANY ORDINANCE IN CONFLICT HEREWITH AND TO PROVIDE FOR THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF ASHLAND, SAUNDERS COUNTY, NEBRASKA, AS FOLLOWS:

### SECTION 1. Section 6-318 Revised and Amended

Section 6-318 of the Ashland Municipal Code shall be revised and amended to read as follows:

### **§6-318 UNLICENSED OR INOPERABLE VEHICLES**

1. No person in charge or control of any property within the City, other than municipal property, whether as owner, tenant, occupant, lessee, or otherwise, shall allow any partially dismantled, inoperable, wrecked, junked, or discarded vehicle to remain on such property longer than thirty (30) days, provided this section shall not apply to:
  - a. where permitted by the City's zoning ordinances and applicable laws and regulations, any partially dismantled, inoperable, wrecked, junked, or discarded vehicle being used for parts may remain on a property indefinitely provided such are fully contained within an enclosed building.
2. No unlicensed vehicle shall be permitted to remain on any private or public property for any length of time, provided that this section shall not apply to the following:
  - a. an unlicensed vehicle fully contained within an enclosed building;
  - b. an unlicensed vehicle on the premises of a business enterprise operated in a lawful place and manner, where permitted by the City's zoning ordinances and applicable laws and regulations and when necessary and essential to the lawful operation of such business enterprise (such as a licensed salvage dealer, motor vehicle dealer, farm implement dealer, or any premises for which a permit to operate a junkyard has been obtained); or

- c. an unlicensed vehicle in a storage place or depository maintained by the City.
- 3. Any vehicle allowed to remain on property in violation of this section shall constitute a nuisance and shall be abated and any person violating this section shall be guilty of an offense.

SECTION 2. Repeal of Prior Ordinances in Conflict

All ordinances and parts of ordinances passed and approved prior to the passage and approval of this ordinance and in conflict therewith are hereby repealed.

SECTION 3. When Operative


This ordinance shall be in full force and take effect from and after its passage, approval and publication according to law.
