SELLER'S RULES

Silver Street Flea Market • Downtown Ashland, NE • Sept 11th, 2016

REGISTRATION: Setup times are from **9am to 12pm** on the day of the Flea Market. It is important that you first register before you set up your items for sale. The registration table will be located at 15th and Silver Street. You will be assigned a numbered space to place your items. The Flea Market will take place **Rain or Shine**. Please note that **registration fees are non-refundable**.

SETUP: All items should be placed in your assigned space before 12pm. You should organize your items in your space so they can be viewed easily by buyers. You can bring tables to display your items in your assigned space. It is important that your items stay within your assigned space until they are sold. Tents are welcome, but must stay within the boundaries of your assigned space.

SALE TIMES: Items can be sold any time from **12pm (noon) until 5pm** on the day of the Flea Market.

SIDEWALKS: The sidewalks must be kept clear for the safety of pedestrians.

VEHICLES: Your vehicle can be used to transport items to your rented space(s) before the Flea Market begins at 12pm. However, it is important that you do not block Silver Street or other rental spaces with cars or other vehicles after 12pm.

PRICING: You are responsible for pricing (tagging) and selling your own items. Collecting money from buyers is also your responsibility.

RESTRICTED ITEMS: You cannot sell Firearms, Liquor, Offensive material or any items that may be considered as Dangerous or Hazardous at the Flea Market.

THEFT OR DAMAGES: The Ashland Area Chamber of Commerce is not liable for theft or damage to your items or property. You are solely responsible for the security of your items for sale. If it rains, you are responsible for covering and protecting your items.

UNSOLD ITEMS: You are responsible for removing your items that were not sold. All unsold items in your rented space(s) **must be removed within one hour after the close of the Flea Market**. If you do not remove your unsold items, you will be charged a disposal fee based on the items removed.
