The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. She said 11 years ago the City restructured water/sewer rates and she currently pays \$50 more per month because she is a licensed Family 1 Childcare Provider. She asked the Council to reduce the in-home daycare utility rates back to the residential rates. City Administrator Quady said there are currently 11 daycares and 18 home businesses including the daycares paying a commercial rate. Kasuske answered questions of the Council. Council Member Mollhoff said the Council is looking at this with the budget. Discussion was held on holding a rate study committee meeting. Heather Kennedy discussed the other expenses that daycare providers have. Lucy Shuster spoke about how the extra money could be used for activities. Quady said a change would be by ordinance. Mayor Grauerholz asked that this tentatively be placed on the first meeting in September's agenda.
