## ASHLAND CITY COUNCIL REGULAR MEETING

February 1, 2018

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 1st day of February, 2018 at 7:00 p.m.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Quady said Cooper Road could be added in the future if the City is interested in paving it. Ron Styskal stated he is concerned about the rock that has washed down into storm sewers from Dale Street. Quady will also find out if the price per pole will be cheaper if bought in conjunction with the poles for the new bridge.
