March 21, 2019

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 21st day of March, 2019 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on March 14, 2019. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Mayor Grauerholz opened a Public Hearing on the Application for Nebraska Affordable Housing Trust Funds at 7:02 p.m. Jim Warrelmann of Southeast Development District (SENDD) spoke to the Council about the Trust Fund Grant the City of Ashland has agreed to apply for on behalf of the county. He stated that participating communities will contribute to the program with a 10 percent match. He said they are in the process of taking pre-applications to determine the total amount of the grant. He said all the funding and paperwork will funnel through Ashland. He added SENDD will sign housing management and administrative contracts with Ashland to manage and pay for the program out of grant

funds. He answered questions of the Council. Ashley Larsen stated the communities that have expressed interest in participating are Ceresco, Cedar Bluffs, Wahoo, Prague, and Yutan. She added she has been communicating with Mead about participating. Warrelmann said the pre-application was for \$300,000 but with a budget of \$315,000 the grant application will be for at least \$315,000; and the match would need to be \$31,500. He said the match is contributed up front and the maximum grant is \$500,000. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:12 p.m.

Lynn Spackman did not appear to speak on parking downtown during snow emergencies.

City Administrator Quady spoke on the writing of a letter to the Nebraska Department of Transportation regarding the proposed Ashland Viaduct Project. She said she wanted to wait until closer to the deadline in April to send the letter to gather additional information. She distributed a proposed letter. Discussion followed. Council Member Gossin said he would rewrite the letter and include additional comment regarding the traffic light.
