ASHLAND CITY COUNCIL REGULAR MEETING

October 6, 2016

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 6th day of October, 2016 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on October 6 and posted at the Bank of Ashland, Farmers and Merchants Bank of Ashland, Ashland Post Office and City Hall on September 29, 2016. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Troy Johnston of JEO Consulting Group Inc. presented the Council with the Bid Tab for the 2016 Ashland Parking Lot Improvements that were let on October 4, 2016. Johnston said there were seven bids, that his bid estimate was \$200,000, and that the apparent low bidder was TR Construction of Bennington at \$184,515.27. He said that their start date would be November 1 on one of the lots, probably the southeast lot.

Motion by Mollhoff, seconded by DeVries to award the bid to TR Construction, Bennington Nebraska for a total of \$184,515.27 to start on November 1st.

Johnston answered questions of the Council.

Shirley Niemeyer spoke to the Council regarding a tire recycling opportunity with the Keep Fremont Beautiful organization that has a grant from the Nebraska Department of Environmental Quality. She said she has spoken with Lee Sapp who would assist, they would like to park a truck on City property for tire collection from residents in the City limits, they would use a donated box truck to transport the tires to Fremont and they could pick up tires if needed from residences. She said she is not sure if they are going forward with this project as she is waiting to hear if there will be sufficient space for their tires. She said for the grant record keeping everyone who brings in a tire will have to sign a form, any business that deals with tires would not be able to bring tires and there is no cost to bringing a tire in. She further discussed details of the collection which is scheduled for November 4th. City Administrator Quady will coordinate a location for the collection with Niemeyer if participation is approved by Keep Fremont Beautiful.

Shirley Niemeyer spoke to the Council regarding the location of the Towers of History. She said there have been commitments of \$24,200 toward the project. Niemeyer discussed some possible location options on the NRD ground and in the parking lot at 13th and Silver Streets and possible tower designs. She said the project may be eligible for the Nebraska Sesquicentennial celebration grants program. Council Member Mollhoff stated that it is not feasible at this time to delay the parking lot project for the Tower project that may or may not happen and that if a committee is able to raise the funds a place will be found for the Towers.

Motion by DeVries, seconded by Gossin to approve pay request from JEO Consulting Group Inc. for New Well 2015 in the amount of \$638.00.

City Administrator Quady gave an update on the well project.

Council Member Anderson stated that he wanted to draw the Council's attention to the condition of the alley behind Lee Sapp Ford as the alley continues to cave in with the

heavy traffic. City Administrator Quady said that the alley can be placed on the priority list for future paving projects and repairs. Anderson said the alley cracks need to be tarred.

Council Member Anderson spoke regarding the alley behind 725 Cedar Street. He said he is concerned about the deteoriation of a City alley possibly caused by loss of vegetation on a nearby property. City Attorney Fahleson and possibly the engineer will look at the condition of the alley to determine if any action can or should be taken.

Motion by Mollhoff, seconded by Anderson to approve HNR Outdoor Designs Trail invoice and change order in the amount of \$13,901.00.

City Administrator Quady noted that this is the final payment for the trail and the funds will be recouped as FEMA pays actual cost.
