A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 20th day of December, 2018 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on December 13, 2018. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Janece Mollhoff gave public comment thanking the Council, Mayor, City Attorney and City staff for their assistance during her tenure on the Council. She added that she and City Administrator Quady had been talking with OPPD about LED street lights as they will save the City about 25% per year on a \$60,000 street light bill. She said last week the OPPD board voted to start the transition to LED street lights in 2019.

Mayor Grauerholz opened a Public Hearing on Conditional Use Permit for Exterior Alterations at W 12' Lot 1 & E 26' Lot 2 Block 31 Flora City Addition, located at 1411 Silver Street at 7:05 p.m. Zoning Administrator Isom spoke for the applicant Bob Luebbe, stating this building is on the south side of Silver Street with brick painted different colors that is chipping and fading that he is wanting to repaint. She said the Historic Preservation Committee requested the application be held over one meeting so she could check on the artistic significance of the painted bricks. She said she talked with the former building owner and found none. Isom reviewed the color choices. She added the Historic Preservation Committee and the Planning Commission both recommend approval of the permit. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:09 p.m.

City Attorney Fahleson explained the material changes to the handbook. He said many were updates to comply with changes to law since the last time the handbook was approved.
