December 3, 2020

A regular meeting of the Ashland City Council was held at the Ashland Community Resource Center on the 3rd day of December, 2020 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on November 26, 2020. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act located on the south wall of the room.

Erika Straight was introduced. She is a student at Ashland-Greenwood High School attending the meeting for a Civics class.

Council Member Crnkovich arrived at 7:03 p.m.

Motion by Wischmann, second by Niemeyer to introduce and approve Resolution 2020-19 – Masks for Covid-19.

City Attorney Fahleson said the resolution would express the City's desire to strongly encourage residents and visitors of the City to wear masks and social distance. He said

some cities have mask mandates but are not enforcing the mandate. Council Member Niemeyer said he believes this is a very good step. Mayor Grauerholz said he talked to many people and businesses in reference to this today and two out of three were not in favor of a mandate. He noted that handwashing is doing more to prevent the spread of the virus. City Administrator Quady said the resolution would be posted at the post office, both banks and City Hall. She added it will be reported about in the Gazette and can be posted on Facebook and the website. Crnkovich said this is nice as an educational platform but does not want it to look like a mandate. Fahleson noted it does not have any enforcement mechanism. Council Member Anderson stated he likes this approach. Mayor Grauerholz said he believes this is the proper way to go at this time and if something changes drastically and there is a need to go further, it can be reconsidered at that time. Crnkovich commented on the wording in paragraph three describing how face coverings should be worn and designed and questioned if this is needed.

Motion by Crnkovich, second by Wischmann to amend Resolution 2020-19 by striking every sentence after "feasible." in the third paragraph.

City Administrator Quady reviewed a map of the proposed wellhead area and noted approving the area is the first step in a wellhead plan. She answered questions of the Council. Mayor Grauerholz said this is to protect the purity of the drinking water of Ashland into the future.
