February 6, 2020

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 6th day of February, 2020 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on January 30, 2020. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Susan Cerny addressed the council regarding the previous junkyard site at the Highway 6 and 66 intersection. She noted that she has been communicating with a professor of landscape architecture at UNL who may have some interest in having his students do some work at this site.

Mayor Grauerholz opened a Public Hearing for new Class C Liquor License for RNK Kennedy LLC dba KC's Eastside Saloon at 649 Highway 6 at 7:08 p.m.

City Administrator Quady stated that KC's Eastside Saloon has changed hands and the new owner has applied for their liquor license. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:09 p.m.

Assistant City Attorney Bentzen read the Title of Ordinance 1173.

Assistant City Attorney Bentzen noted that City Attorney Fahleson did change a portion of the language from the first reading. Mayor Grauerholz expressed some concerns about neighbors being confused about their right to shoot if they do not live in the TA district. Grauerholz also mentioned that the police would need to be informed or that could cause a problem.

Quady stated that this was a grant that was received for an expanded wellhead protection plan and would include funds to help surrounding citizens to abandon old wells. Quady also noted that the LPSNRD has agreed to contribute to this project.

Wischmann addressed the council regarding the need to slow traffic down on Clay Street. Quady stated that Police Chief Baudler did sit on Clay for an hour one morning and noted that the large majority of drivers were either under the speed limit or within 5 miles of the speed limit. Wischmann stated he believes that the City should install two additional stop signs on 20th and Clay Streets, creating a four-way stop and switch the stop signs on 18th and Clay, to stop the flow of traffic on Clay instead of 18th Street. Quady noted this would need to be done by a resolution at a future meeting.

Quady informed the Council that during annexation, a couple of residents that live on 30th had inquired about a slower speed limit on 30th Street. Meyer stated that he sees many kids playing on 30th Street and that he feels the speed limit should be lowered.
