January 6, 2022

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 6th day of January, 2022 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on December 30, 2021. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act located on the south wall of the room.

Motion by Niemeyer, second by Anderson to approve Resolution 2022-1 – Engine Braking Fine.

Motion by Wischmann, second by Crnkovich to amend resolution to fine amounts of \$200 and \$250 if not paid after 5 days.

Police Chief Joe Baudler said when an officer hears the jake braking a citation can be issued. He explained that the State of Nebraska is going to require E-Tickets in the future and until then a sticker will need to be attached to the department's current tickets. He said if the fine is not paid the Police Secretary will follow-up with a letter and if still unpaid, it

can be sent to Court. City Attorney Fahleson said the judge may adjust the fine. Baudler said he thinks very few will go to court. He said engine braking often happens when people pull out in front of a semi. He said he sat up by the corner of Highways 6 and 66 and counted about 100 trucks going through with only three violations. Council Member Niemeyer said he is concerned about the trucks coming down the hill on Highway 66. Baudler said he didn't think the proposed round-a-bout will make a difference. He added new trucks don't have this feature. Council Member Anderson said based on the Chief's comments he would like to leave the fine as is. Baudler said he has been talking to truckers about the engine braking and raising the fines. He said the worst time of year is during harvest season. Niemeyer said he would also like to leave it at \$100 and see how it goes.

Mayor Grauerholz called for a vote on the amendment to Resolution 2022-1.
