A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 16th day of June, 2022 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on June 9, 2022. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act located on the south wall of the room.

Mayor Grauerholz opened a Public Hearing on new Liquor License for Ashland Wine & Spirits LLC dba Ashland Wine & Spirits at 202 Highway 6 at 7:03 p.m. Aakash Bhoja spoke introducing Sonny Patel as owner of the new store. Bhoja said Patel has been training with him the last two years at his store in Gretna. He said depending on the rain, they hope to be ready to open in two weeks. With no further comments, Mayor Grauerholz closed the Public Hearing at 7:06 p.m.

Mayor Grauerholz opened a Public Hearing on Application #22-011 for Conditional Use Permit located at 109 and 111 North 14<sup>th</sup> Street, Ashland Nebraska at 7:06 p.m. City Administrator Quady stated this is for the old Washburn building that is being remodeled by Brian Whitehead. She said the Historic Preservation Committee and Planning Commission recommended approval of the permit. She said the permit is for replacing the windows, doors and awning. She said Whitehead isn't sure if there will be one entrance with the building next door or if it will be two separate buildings. She said he is still working with engineers on the plan. Building Official Krejci said the building has been demoed and cleared out and it was in better shape than anticipated. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:10 p.m.

City Administrator Quady spoke to the Council about the new League Insurance Government Health Team (LIGHT) program. She said the insurance would be through Blue Cross and Blue Shield (BC/BS of NE) and will be between \$2000 and \$3000 cheaper each month from what we are currently paying BC/BS of NE. She said there are about 20 communities that are starting the program in July. She said the insurance will provide the same coverage but the deductible is a little lower. She recommended that the Council approve the resolutions for the interlocal agreement and for designating her as a member of the LIGHT Board of Directors.

City Administrator Quady said this will extend the contract for another year. She said no houses have been approved in Ashland but SENDD has applications for Ashland they are reviewing.

Lowell Krueger, owner of nuisance property at 106 South 16th Street, spoke to the Council regarding work on the house foundation. He reviewed two photos showing the block work he is finishing this week or the first of next week. He said this is on the southside and the last outside wall. Council Member Crnkovich asked questions of Krueger. In response, Krueger said there were still some older parts of the foundation that are in existence that he might want to redo. He added he would like to dig out the north wall, put in a French drain and seal it. He said if that goes well he might take out a little more foundation or start on the front porch. He said he will be able to drop the house back down on the foundation once the block wall is done. He said there are no windows out. Council Member Wischmann said when the Council initially started talking about the property, they asked that the house be habitable within the time period of one to two years. He said this process started in 2020. He said it is now 2022 and it is neither sealed up nor habitable. He asked what will make him believe that within the next six months, this house will be habitable. Krueger said it is not necessarily a possibility. Wischmann said then it needs to be sold or knocked down. Building Official Krejci said where the French drain is, Krueger has a section of wall out. Krueger said the scope of the current building permit is for the foundation. Wischmann said Krueger has been doing work upstairs that is out of the scope of the permit. Krejci said Krueger has to pour the basement floor. Krueger said he could not do this work in a month. Krueger added it has been a lot of work and steady progress. Wischmann said he doesn't see anything that will lead him to believe this will be done anytime soon. He said he has given Krueger extension after extension and that he will not do it again. Crnkovich said if a team was brought in this could be done super fast but he understands that Krueger wants to do it himself. Wischmann said Krejci has not been able to inspect the upstairs or allowed access. Discussion continued.

Motion by Crnkovich to grant an extension to the completion of the scope of the building permit to the next meeting.

Wischmann said this would include the floor and the French drain. City Administrator Quady said this would be July 7.

Motion died due to lack of a second.

Wischmann said the City will now move forward with abatement. City Attorney Fahleson said the abatement triggers automatically with no extension. City Administrator Quady said she will get bids for removal of the house. City Attorney Fahleson read the nuisance abatement procedures. Discussion on procedure and timeline for abatement if the property is sold. Mayor Grauerholz clarified the options will be to either remove the structure from the property or to sell the property with the disclosure that the nuisance is to be abated within 90 days. Council Member Anderson said he is in favor of abatement.
