A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 21st day of June, 2018 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on June 14, 2018. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Mayor Grauerholz opened a Public Hearing on an application for a Class C Retail Liquor License by Glacial Till Vineyard & Winery LLC at 1419 Silver Street at 7:04 p.m. Mike Murman, owner of Glacial Till, said they recently started making hard cider and in the State of Nebraska hard cider is classified as beer. He said for regulatory reasons they needed to divide out their cider production from the wine production which required an additional liquor license for the cider side of the business. He said operations will be identical to what they have been at the tasting room. He said there is a lot of construction underway and he will be back in six to eight months to enlarge the licensed area. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:06 p.m.
