ASHLAND CITY COUNCIL REGULAR MEETING

June 7, 2018

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 7th day of June, 2018 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on May 31, 2018. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Motion by Anderson, seconded by Mollhoff to adopt the regular agenda.

Melody Dobson spoke on behalf of the American Doorstop Project about a documentary film they are producing about the impact of thoroughbred horse racing in Nebraska. She noted Ashland would be one of the communities featured in the film.

Mayor Grauerholz reopened the continued public hearing on Ordinance 1151 – Vacate a Portion of 12th Street, 13th Street, Ash Street, Birch Street and adjacent Alleys at 7:06 p.m. Bob Luebbe spoke regarding the campground project in this area. He provided a printout of an updated design showing camper pads in relation to existing City streets and alleys. Luebbe said the design takes into account the proposed regulations requiring 15-feet clearance from a combustible structure for

fire pits. He said the roads will be one-way; not all campsites will be built out initially; and roads were designed with City utilities in mind to minimize paving over the utilities. He said he read through the firepit regulations and thinks they are fine. He said there will be at least 30 feet between each campsite. City Administrator Quady noted who the abutting property owners are to each portion of roads and alleys to be vacated. She said the vacation needs to be completed prior to the easements being set. With no further comment, Mayor Grauerholz closed the public hearing at 7:22 p.m.

She clarified the ordinance has nothing to do with grills. Council Member Mollhoff spoke regarding the possible need for a density requirement to address air quality. Mayor Grauerholz noted fire pits are currently illegal and this will make them legal. He said the downtown is a fire zone where no open flames are allowed. Mollhoff said the campground is outside the fire zone. Council Member Gossin questioned if fire pits that are currently built should be grandfathered in. Discussion was held with no further changes to the ordinance requested.
