ASHLAND CITY COUNCIL REGULAR MEETING

May 17, 2018

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 17th of May, 2018 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on May 10, 2018. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

Motion by Anderson, second by DeVries to adopt the regular agenda.

Mayor Grauerholz opened a Public Hearing on Final Plat for 07-12-10 L3 & 4 SL1 of 4 & 5 EXC HWY W1/2 NW 1/4, Cass County, Nebraska at 7:02 p.m. Justin Schmidt, co-owner of the property spoke about their final plat request. He said they have worked with an engineer on a drainage study, perk tests and placement of septic tanks. He said they are ready to start building and selling lots. Zoning Administrator Isom stated the Final Plat was recommended for approval by the Planning Commission as submitted. She noted that when the preliminary plat was reviewed there were concerns expressed by the neighbors; since then the developers have met with several of the neighbors and the issues have been resolved. She said between now and the second reading the subdivision agreement will be reviewed. Schmidt said they would like to begin moving dirt for the road and installing the power in the next month and half. Council Member Anderson said

that it is unfortunate that the subdivision won't be on City water. Eric Downing said the subdivision agreement will include that lots can't be subdivided and when water and sewer becomes available the property owner will have to hook on. Isom said that she will add a note on the building permits regarding the need to hook on to services when they are available. With no further comment, Mayor Grauerholz closed the Public Hearing at 7:14 p.m.

Mayor Grauerholz opened a Public Hearing on proposed Ordinance 1151 to Vacate a Portion of 12th Street, 13th Street, Ash Street, Birch Street and adjacent Alleys at 7:14 p.m. Assistant City Attorney Bentzen recommended the public hearing be continued to the next meeting as the documents are being revised. Anthony Aerts, attorney with Rembolt Ludtke, spoke about drafting of the documents for this proposed transaction. He said there have been a couple of questions related to protecting the City's interests in regard to access to the existing public utilities easements and right-of-way. He said there is an additional question about the portion of the right of way that abuts property currently owned by the State. Zoning Administrator Isom stated the Planning Commission recommended approval. Mayor Grauerholz held over the Public Hearing until the next meeting at 7:17 p.m.

Mayor Grauerholz opened a Public Hearing on Conditional Use Permit for a Domestic Dog Kennel at Lot 66 & S ½ Lot 67 Kendel Heights Addition to Ashland, located at 407 North 27th Street at 7:17 p.m. Zoning Administrator Isom spoke about her application for the kennel permit. She said that she has three dogs and a fully fenced backyard. She added the Planning Commission recommended approval. With no further comments, Mayor Grauerholz closed the Public Hearing at 7:19 p.m.

Motion by Gossin, second by DeVries to approve on third and final reading of Ordinance 1150 – AN ORDINANCE TO CHANGE THE ZONING DISTRICT BOUNDARIES OF THE CITY OF ASHLAND, NEBRASKA, AS PROVIDED IN THE CITY OF ASHLAND MUNICIPAL ZONING ORDINANCE; TO AMEND THE CITY'S FUTURE LAND USE MAP; TO AMEND THE CITY'S OFFICIAL ZONING MAP; TO PROVIDE FOR THE EFFECTIVE DATE THEREOF; TO ORDER THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM. Assistant City Attorney Bentzen read the Title of Ordinance 1150.

Assistant City Attorney Bentzen read the Title of Ordinance 1153.

City Administrator Quady said there are fire pits in town and the City does not have any ordinances that address fire pits other than open fires are not allowed in town. She said this is coming before the Council as a request by the owner of the potential campground and that owner's desire to have firepits. Discussion was held regarding the density of campgrounds and the distance required from a combustible structure. Zoning Administrator said this is needed for firepits in town too. Mayor Grauerholz mentioned the screen requirement and the fire zone in the downtown district. He added fire pits are permitted during community events downtown. Quady said this could be included on the street closure form as the only way fires are allowed downtown. Quady added she would include wording for permanent or temporary/moveable fire pits. Grauerholz recommended the addition of wording related to the size of the pits. Council Member Gossin asked for thoughts on grandfathering in existing fire pits.

Assistant City Attorney Bentzen read the Title of Ordinance 1154.

City Administrator Quady said the only thing that has changed from our current regulations is to remove the requirement on the Mayor and City Council that they can hold no other appointed position in the City. She said that because of this current requirement the Mayor and Council are not able to serve on an elected office in the fire and rescue departments or other appointed positions. Mayor Grauerholz said that when he took the position of Mayor he had to give up the volunteer work he was doing with the fire and rescue departments. Quady said the Council and Mayor cannot be an employee of the City.

She said they have used this for years; this will be for a farm easement; and it will be recorded with the County. She said this is the farmer that farms the City's property.
