October 3, 2019

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 3rd day of October, 2019 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on September 26, 2019. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act is posted on the south wall of the Council Chambers.

ORDINANCES OF THE CITY OF ASHLAND, AS PROVIDED IN THE CITY OF ASHLAND MUNICIPAL ZONING ORDINANCE; TO PROVIDE THE EFFECTIVE DATE THEREOF; TO ORDER THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM.

City Attorney Fahleson read the title of Ordinance 1166.

Zoning Administrator Isom stated that filing fee for a conditional use permit is \$300.00. Council Member Gossin said he had not received any other comments from the public on this since the last meeting. Isom and other Council Members indicated they had not received any either. He confirmed with Isom that the Planning Commission did vote to at least make self-storage conditional.

City Clerk Sliva reported Glacial Till will be sending the request for SDL recommendations as people and organizations book the room so the Council will be seeing dates far out in the future. She added that the tasting room may not be granted approval by the Liquor Control Commission as only 12 SDL's may be issued for the same address in a year and they have met that maximum but that the owner is sending a letter to the Commission requesting this rule be waived. Council member Gossin asked if the Council should send a letter of support to the Commission and requested Sliva contact the owner to ask if this would be helpful.

Council Member Anderson said that Council Member Wischmann's dad will remove the trailer at no charge, cut it up and recycle it. He added the City may need to push some trees out of the way to make it easier to access the trailer. Fahleson said under the court order the volunteer trees can be removed.

Council Member Anderson addressed the Council regarding maintenance and repair of the paved alleyways in the downtown business district. He said these alleys have been taken care in the past by the City. He added he thinks the ordinance should be amended to state as such. The Council's consensus was to have a draft amendment written to be presented to the Council for consideration.

Mayor Grauerholz suggested that at the upcoming workshop an agenda item could be a discussion on requesting activity or staff reports.
