A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 1st day of September, 2016 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on August 25, 2016. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Grauerholz called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Mayor Grauerholz noted the Open Meetings Act that is posted on the south wall of the Council Chambers.

She said she had presented the information to the Planning Commission. She said that she will be making people aware of the change perhaps with an article in paper prior to enforcement so people can begin making plans to remedy this. She answered questions of the Council.

Jerry Froistad spoke to the Council regarding replacement lighting in the Carnegie Library for the Ashland Historical Society. He said the first phase of blocking out UV light in the museum is complete with the installation of window shades. He said they are moving to the second stage of placing UV blocking tubes over the bulbs at a cost of \$300-\$500. He said that an electrician has made a recommendation to move to the T-8 bulbs that would be more efficient, uniform and all working. He added that the electrician gave a bid of \$130 per light and a total of \$1500 for 10 lights including the installation of the UV tubes. Froistad requested that the City financially assist with the project as the owner of the building. Council Member Mollhoff suggested that the Society look into possible grants for the project. The Council requested Froistad look into the grants and then put the item on a future agenda.

Troy Johnston of JEO Consulting Group presented the Council with plans and specs for the proposed parking lots at 13th and Silver and 14th and Adams. He said the one on the southeast corner of 13th and Silver will have curb and gutter installed and replaced. sidewalk replaced on the north and west sides, and the lot will be 7-inch concrete with 28 regular stalls and 2 handicap stalls. Council Member Anderson mentioned that the installation of the proposed Towers of History was considered at this site. City Administrator Quady stated that she has budgeted \$200,000 for the parking lot projects and if the bids come in at the estimated \$230,000, she believes that the City will be able to cover the difference. Johnston said the parking lot at 14th and Adams will have new curbing and a boundary survey was completed. Discussion was held regarding the lot's neighboring properties, Reliable Plumbing and the Buckmaster lot. Assistant City Attorney Bentzen told the Council that the City is in the process of obtaining the tax certificates for the Buckmaster lot and once the City has obtained the deed a discussion can be held about keeping the lot for a secondary access to the alley or selling the property. Johnston said the lot would have 32 regular stalls and two handicap stalls. City Administrator Quady noted the locations of the charging stations. Council Member DeVries noted that there may be a need for longer stalls to accommodate trucks. Johnston said stalls could be lengthened along one side of the Silver Street lot. Johnston suggested a bid letting date of October 4th with the awarding at the October 6th Council meeting. He said that the estimated construction cost with a 5% contingency fund is \$232,000. Quady said that the project will be paid for through the general fund and bonding. John Craven, owner of Reliable Plumbing, suggested that Council consider the purchase of his lot and building. Discussion followed.

Motion by DeVries, seconded by Gossin to approve parking lot plans and specs with the additional long parking spots in one tier of stalls in the Silver Street lot with a bid letting date of October 4, 2016.

Richene Perkins, owner of 601 South 8th Street, addressed the Council regarding her property which has been declared a nuisance. She stated that she was not been able to be in contact with any potential buyers. She said she had moved some items out of the house but there are still other personal possessions in the house and she would like an additional extension to move them out to a storage container or unit. Council Member Anderson told Perkins that she needed to move her items out. Council Member Mollhoff said that the City needs to move ahead with abatement as this process was started four years ago. When questioned, Perkins said she would like to rebuild the house. Council Member Anderson asked City Administrator Quady to obtain another demolition bid to be done this winter giving Perkins time to remove items. Quady said if the house remains it must be habitable and if the City abates the nuisance it will tear the house down. Council Member DeVries said that the Council needs to see concrete plan and action being taken on the property. Council Member Gossin gave Perkins a list of items that can be done in two weeks time including identifying a storage unit where items could be stored, get bids on the pod, contact the two potential buyers, placing an ad in the Ashland Gazette for the property or if she desires to keep the property, obtain a contract with a contractor with a start date to repair the property.
