A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 4th day of September, 2025 at 6:00 p.m.

The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. Mayor Anderson called the meeting to order at 6:00 p.m. The Pledge of Allegiance was recited. Roll Call was taken, and a quorum was declared. Anderson noted the Open Meetings Act located on the south wall of the room.

City Administrator Quady stated the purpose of this is in the event the owner of a property cannot be located to serve in person or by certified mail, as this is the only other option available. Assistant City Attorney Kurth Brashear read the title of Ordinance 1523 in full.
